THE JURIED ARTIST MUST HAND CRAFT ALL WORK.

IF YOU DID NOT HAND MAKE IT, DO NOT BRING IT. PLEASE LEAVE YOUR WHOLESALE ITEMS AT HOME.

PLEASE DO NOT SEND BOOTH FEES WITH THIS JURY APPLICATION.

If you are accepted as a vendor, you will be sent a contract, at that time you will return the completed contract with your booth size choice and booth fees. We do comprehensive advertising in newspapers, radio, television and national magazines. If you are accepted, we will provide flyers to distribute at your other arts and crafts shows and in your community.

Please fill out the enclosed application and submit with **5-6 quality photos** of your work and **1 of your booth**.

(NO slides, CD's, DVD's or merchandise will be accepted; the jury committee meets as a group and does not have access to equipment to look at slides, CD's or DVD's). Also, please include **3-4 pictures of your work-in-process**. Close-up photos of your work enable the jury committee to select the highest quality crafts.

Remember: Photos speak for you as they are presented to the jury committee.

A \$5.00 jury fee is required. Please make your check payable to Illinois Heartland Decorative Artists (IHDA) and forward it along with your **photos and application as soon as possible to:**
